On 20 July 2016, the Company entered into three Huadong Cares Subcontract Agreements with Huadong Cares, pursuant to which the Company has agreed to subcontract to Huadong Cares respectively: (i) the construction of the security inspection information system for the Shangrao Airport Project, which includes, but not limited to, the procurement, installation and testing of the required software and hardware and the overall system implementation and the one-year quality warranty for the security inspection information system; (ii) the construction of the GSM system, Wechat platform and flight control system for the Chongqing Airport Project, which includes, but not limited to, the procurement, installation and testing of the required software and hardware and the implementation of the GSM system, Wechat platform and flight control system and the two-year quality warranty for the systems mentioned above; (iii) the overall construction of the self-service check-in system for the Jinan Airport Project, which includes, but not limited to, the procurement, installation and testing of the required hardware and the overall system implementation and the one-year quality warranty for the self-service check-in system.

On the same day, the Company entered into the Xiamen Cares Subcontract Agreement with Xiamen Cares, pursuant to which the Company has agreed to subcontract to Xiamen Cares the construction of the security inspection information system for the Chongqing Airport Project, which includes, but not limited to, the procurement, installation and testing of the required software and hardware and the system implementation and the two-year quality warranty for the security inspection information system.

Since each of the highest applicable Percentage Ratio calculated with reference to (i) the Huadong Cares Subcontract Agreements on an aggregate basis; and (ii) the Xiamen Cares Subcontract Agreement, respectively, is more than 0.1% but less than 5%, the transactions contemplated thereunder constitute connected transactions of the Company and are subject to the reporting and announcement requirements but exempt from the independent Shareholders' approval requirement of Chapter 14A of the Listing Rules.

## III. REASONS FOR AND BENEFITS OF THE CONNECTED TRANSACTIONS

The Company has undertaken the Shangrao Airport Project, Chongqing Airport Project and Jinan Airport Project as the general contractor. Huadong Cares and Xiamen Cares are principally engaged in the provision of computer software and hardware development and data network services. Each of Huadong Cares and Xiamen Cares has the necessary qualifications, capabilities and technological skills required to carry out the relevant works as specified under the Huadong Cares Subcontract Agreements and the Xiamen Cares Subcontract Agreement, respectively. The Board is of the view that it will be for the benefit of the Company to subcontract to Huadong Cares and Xiamen Cares the relevant work as specified under the aforementioned subcontract agreements.

The Directors (including the independent non-executive Directors) are of the view that the transactions under the Huadong Cares Subcontract Agreements and the Xiamen Cares Subcontract Agreement will be conducted in the ordinary and usual course of business of the Group and on normal commercial terms, and that the terms of the transactions are fair and reasonable and in the interests of the Company and the Shareholders as a whole.

## IV. IMPLICATIONS UNDER THE LISTING RULES

Huadong Cares is owned as to 41% by the Company and over 30% by Eastern Airlines as at the date of this announcement. Eastern Airlines is a subsidiary of Eastern Holding, the substantial shareholder of the Company. As such, Huadong Cares is a connected person of the Company under Rule 14A.07(4) of the Listing Rules. Therefore, the transactions contemplated under the Huadong Cares Subcontract Agreements constitute connected transactions of the Company.

Xiamen Cares is owned as to 51% by the Company, 28.5% by Xiamen Airlines and 20.5% by Xiamen Aviation as at the date of this announcement. Xiamen Airlines is a subsidiary of Southern Holding, a substantial shareholder of the Company. Xiamen Cares is therefore a connected person of the Company pursuant to Rule 14A.07(5) of the Listing Rules. As such, the transactions contemplated under the Xiamen Cares Subcontract Agreement constitute the connected transaction of the Company.

Since each of the highest applicable Percentage Ratio calculated with reference to (i) the Huadong Cares Subcontract Agreements on an aggregate basis; and (ii) the Xiamen Cares Subcontract Agreement, respectively, is more than 0.1% but less than 5%, the transactions contemplated thereunder constitute connected transactions of the Company and are subject to the reporting and announcement requirements but exempt from the independent Shareholders' approval requirement of Chapter 14A of the Listing Rules.

Mr. Li Yangmin has abstained from voting on the resolution in relation to the Huadong Cares Subcontract Agreements as he is a director of Eastern Airlines. Except for the above, none of the Directors has a material interest in the transactions contemplated under the Huadong Cares Subcontract Agreements, and none of them has abstained from voting on the relevant Board resolutions.

Mr. Yuan Xin'an has abstained from voting on the resolution in relation to the Xiamen Cares Subcontract Agreement thereunder as he is a director of Southern Holding. Except for the above, none of the Directors has a material interest in this regard and none of them has abstained from voting on the relevant Board resolutions.
